WTT CORPORATE COUNSEL

World Table Tennis (WTT) is a commercial entity created by the ITTF to grow the professionalisation of table tennis by running ITTF's commercial and events business. Taking a new, innovative and entrepreneurial approach to how table tennis should manage its competition platform and positioning, WTT has been tasked with re-imagining a new professional event structure, re-energising the entertainment and fan experience, and re-defining the new era.

WTT is seeking a meticulous and logical Corporate Counsel who has business acumen and will be responsible for managing day-to-day legal needs in World Table Tennis.

RESPONSIBILITIES

- Partner with various Departments and manage the entire contracting process (from request, drafting and negotiation to execution and discharge or renewal) for a wide variety of contracts, including event rights, brand partnerships, IP licenses, agency, consultancy and services agreements.
- Support in IP commercialisation and protection, such as overseeing trade marks portfolio, licensing IP rights and issuing take-down notices.
- Support in managing commercial disputes and sports-related regulatory actions.
- Serve as the Data Protection Officer for WTT and its subsidiaries (where applicable) and manage their DPMP.



- Provide secretarial support for WTT Boards, Committees, and such official bodies, when requested.
- Liaise with and manage external counsels and other legal service providers when engaged.
- Support the ITTF Group's Legal Department as needed.
- Render efficient and practical general legal advice as needed.
- Support in legal aspects of major projects.
- Any other task as assigned by the ITTF Group Head of Legal & Corporate Affairs..

REQUIREMENTS

Essential:

- LLB / JD or equivalent degree from a reputable university.
- Minimum 3 years of relevant experience across a broad spectrum of legal work.
- Excellent written, presentation and communication skills.
- Strong interpersonal skills and possess business acumen.
- Ability to work under tight timelines and pressure.
- Organised, meticulous and detail oriented.

Desirable:

- Ability to work in multiple languages, with preference for South East Asian Languages.
