You will be work closely with the Chief Ethics and Compliance Officer for the AQIU and be responsible for developing and implementing strategies, policies, and initiatives to prevent, detect, and address issues related to integrity, anti-doping, safeguarding and other forms of misconduct in the sport. This position requires a strong background in sports integrity, regulatory compliance, and leadership skills.

Main Responsibilities:

Your main responsibilities will be as follows but not limited to:


Integrity strategy:

• With closely with the AQIU Supervisory Council to develop and implement an overall integrity strategy

Education and Awareness:

- Design and implement education and awareness programs for athletes, coaches, officials, and other relevant stakeholders to promote integrity, ethics and fair play in sports.
- Develop education materials and resources to promote awareness and understanding of sports governance requirements.







Anti-Doping Measures:

Oversee and coordinate anti-doping efforts, including testing protocols, alongside the International Testing Agency.

Investigation and Disciplinary Procedures:

 Establish and oversee effective investigation and disciplinary procedures for integrity-related violations, ensuring transparency, fairness, and due process.

Collaboration and Partnerships:

- Foster relationships and collaborate with national and international sports organizations, law enforcement agencies anti-doping bodies, betting regulators, and other stakeholders to address integrity challenges collectively.
- Represent the organisation in meetings, conferences, and seminars related to sports governance.

Leadership and Team Management:


• Provide strong leadership and guidance to the integrity unit team, fostering a culture of professionalism, collaboration, and continuous improvement.

Education and Experience:

- Minimum 5 years' experience in sports integrity, regulatory compliance, or related fields with demonstrated experience in anti-doping, match fixing or other integrity related matters.
- In-depth knowledge of international and national sports integrity regulations, including those set by relevant governing bodies (WADA, IOC etc)
- Strong understanding of the sports industry, including the structure of sports federations, governance models and stakeholder relationships.
- Familiarity with investigation and disciplinary procedures preferably within the sports context.
- Excellent analytical, problem-solving, and decision-making skills with the ability to handle complex integrity issues.
- Excellent communication and interpersonal skills to collaborate with stakeholders at various levels, including athletes, coaches, officials and external partners.
- Demonstrated ability to work independently, prioritize tasks and meet deadlines in a fast-paced, sometimes high-pressured environment.
- Integrity, ethics, and a commitment to upholding the values of fair play and sportsmanship.
